MAG-FILER's security features include password protection, Social Security Number truncation and TIN verification. Any recipient forms will display a truncated SSN to protect clients' sensitive information. The TIN verification feature matches TINs from the forms to the IRS database, checking for input errors before forms are e-filed.

### **Reporting – 4.5 Stars**

MAG-FILER offers unlimited federal and state e-filing directly through the IRS and SSA websites. In addition, the software keeps a log of previously submitted forms and summary reports. Users can sort through and filter recipient data and print totals reports, showing summary amounts for all payee files. Forms can be saved to PDF and emailed to recipients or exported to CSV format. Users can also open the program's data using Microsoft Access.

MAG-FILER also offers a comprehensive option that will print, e-file and mail copies of forms to recipients.

### **Import/Export Capabilities – 4.5 Stars**

Users can import files and data from Excel, QuickBooks and text data formats. Data from the previous tax year can also be rolled over into the program. MAG-FILER supports exporting to CSV and PDF formats and electronic distribution via email.
