

Available only as an on-premise product, users can quickly download a demo of the product to try out prior to purchasing. The main user interface is easily navigated, with a drop down menu bar at the top of the screen, with access to system functions such as Checks, Employees, Forms, Reports, Company, and Vendor Center available in a vertical menu on the left side of the user interface screen. A Step-by step wizard is included in the product that will guide new users through common tasks such as creating a new company and adding new employees. Users can also create new checks, backup and restore data files, generate direct deposit files and export to other applications from this screen.

Company employees are organized in a tabular view, with users able to quickly view employee information. New payroll checks can also be created through the tabular display as well. Users can also view all processed checks, with the ability to sort checks using a variety of filters such as current month, current quarter, current year, or last year. Users can also view a preview of all checks that are being processed, with the ability to make edits to checks prior to processing.

Payroll Mate supports multiple pay frequencies including weekly, biweekly, semimonthly and monthly payroll processing, and supports multiple pay types as well, including regular salary, hourly pay, overtime and double time pay, bonus pay and commissions. Payroll Mate also offers both vacation and sick pay accruals, which can be tracked in the system, with totals reflected in each pay stub. Users also have the option to override these totals if they're incorrect.

Other feature in Payroll is the ability to handle unique payroll situations such as Income per Piece, income per mile, and farm payroll, and their integrated 1099 processing is able to prepare 1099's for contractors. The product handles state withholding for all 50 states, and the District of Columbia.

The product only supports reporting for a few states, including California DE-9, California DE-9C, Texas C-3, Texas C-4, New York NYS-45, Illinois 941, and Illinois UI-3/40, and Florida RT-6. Processing of ACA 1095-C and 1094-C forms is also available from 1095 Mate Software, which is an add-on to the payroll product.

Payroll Mate integrates with other Real Business Solutions products such as W2 Mate, which processes W-2's and 1099's. Other add-ons are available that are designed to increase product functionality, including MICR Printing, Direct Deposit, State Payroll reporting for IL, TX, CA, FL, and NY, and 1095 Mate, which processes ACA 1095-C and 1094-C forms.

The product also integrates with QuickBooks products, Sage 50, and Quicken applications, as well as other applications that can import CSV files. Payroll Mate can also import employee and payroll setup information from applications such as QuickBooks, Sage 50, DacEasy, Kronos, ADP, Paychex, PeopleSoft, and others.
