Intacct allows users to easily create custom templates for system invoices sales order, purchase orders and statements using Microsoft Word. Users can create a new invoice using the Quick Invoice Entry Preferences screen, which allows users to autopopulate the new invoice based on the prior invoice. Users can also create a new invoice from scratch, and can attach any relevant documents to the invoice when entering information. There is also an option to create a recurring invoice, where users can also customize start and end dates, invoice frequency, which includes day, week, month, or year.
