The product offers basic reporting capability, with standard payroll reports such as Payer/Tax Summary and Employee Detail reports available. AMS Payroll report customization capability is limited to various multiple selection criteria, field inclusion/exclusion and subtotal by category/date. Reports can be exported to a text file or to Excel via a tab-delimited file.

Federal tax form processing and filing is supported, including 940, 941, 943, 944 and many others. These same forms can also be filed electronically, and AMS can also electronically file quarterly state tax returns for 29 states, which potential users can review on the AMS website prior to purchasing.

AMS Payroll does not offer direct integration with any timekeeping applications, but product users can import data using tab-delimited text files.

AMS Payroll is an add-on module for W-2/1099 Forms Filer, which is required in order to use the payroll application. The product also integrates with other AMS products including 1042-S Filer, ACA Filer, E-File Direct, and Software Generated Forms. Integration with third party applications are limited to importing and exporting data to or from QuickBooks, Sage 50, and Excel.

AMS Payroll offers 40 user-defined fields that allow product users to easily track additional employee and HR details, but the product does not currently offer any HR tools.

Solid help functionality is available throughout AMS Payroll, and the product also offers a series of product tutorials, which can be accessed from the AMS website. Software
