What would you suggest to accounting firms that are interested in retaining and advancing more qualified female staff?

Recognize that firms are better with women (and under-represented minorities) at all levels within the organization and commit to goals to promote women to important leadership roles. Don't make decisions about assignments you assume a female professional would not be interested in- ask them and you'll be surprised at how wrong your assumptions can be. Focus on opportunities for development, mentoring and remember it's critical to ensure there is sponsorship at the right level among leaders in the firm.
