

What do you feel is the most important issue facing the accounting profession today?

The accounting profession is at a pivotal moment. Our profession will undergo more transformational change in the next five years than in the past 50 years.

Transformation is key to our profession's continued success. I was asked to create a new vision from scratch and bring it to life. It was one of the biggest risks of my career, but also one of the moments that gives me the most pride. Owning your career and taking risks that highlight your strengths is necessary for success.
